SUBJECT: NOTICE UNDER SECTION 8 OF THE DEFAMATION
ORDINANCE, 2002.

Dear Sir,

This is a statutorily required notice which I address to you on behalf of and under instructions from Mian Muhammad Shehbaz Sharif who is presently holding the office of the Chief Minister of Punjab. I have been instructed by my client to issue and serve upon you a legal notice for defamation as follows:

1. That during the "Breaking News" segment aired/televised on 31.12.2017, by 92 News HD Plus, a channel owned by M/s Galaxy Broadcast (Pvt.) Ltd, wherein the newscaster, along with the Forum Editor of 92 News HD Plus, Mr. Rana Azeem, leveled certain maliciously false, utterly baseless, and completely unfounded accusations, directly and through insinuations, against Mian

Muhammad Shehbaz Sharif, alleging that Mian Muhammad Shehbaz Sharif, along with his brother Mian Muhammad Nawaz Sharif, was called to Saudi Arabia due to a discovery made by Saudi authorities in the course of their investigation into the financial dealings of a Saudi Prince, namely Prince Mishaal Bin Abdullah; that Prince Mishaal told Saudi officials that 3 billion riyals which he invested in Europe was not his own money rather this money belonged to the Sharif family, namely Mian Muhammad Nawaz Sharif, Mian Muhammad Shehbaz Sharif, Mr. Ishaq Dar, and Hussain Nawaz, acquired through corruption; that subsequent to Prince Mishaal's said disclosure Saudi officials instructed the Saudi Ambassador to Pakistan to meet with Mian Muhammad Shehbaz Sharif; that in the aforesaid meeting Mian Muhammad Shehbaz Sharif was asked to depart for Saudi Arabia immediately and he did so on a plane belonging to the aforesaid prince; that Mian Muhammad Shehbaz Sharif met with the committee investigating this matter in Medina, Saudi Arabia and told the said committee that the Sharif family was willing to return the entire amount of money in exchange for a guarantee that the matter will be resolved quietly; and that after the said meeting Mian Muhammad Shehbaz Sharif informed Mian Muhammad Nawaz Sharif, who then flew to Saudi Arabia.

2. That, as a matter of fact and record, Mian Muhammad Shehbaz Sharif did not travel to Saudi Arabia for the reasons and under the circumstances as alleged in the "Breaking News" segment, aired/televised by your channel, the details of which have been presented in the abovementioned paragraph. Therefore, the statements of your channel in this regard were absolutely false, incorrect, and the
